Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Danger! Strong oxidizer. Contact with other material may cause a fire. May cause methemoglobinemia. May cause central nervous system effects. May cause cardiac disturbances. May cause liver and kidney damage. May cause severe eye, skin and respiratory tract irritation with possible burns. Target Organs: Blood, kidneys, central nervous system, liver,

- Inhalation: to deficient oxygenation of the blood), convulsions, tachycardia, dyspnea (labored breathing), and death. May cause liver and kidney damage. May cause cardiac abnormalities. May cause acute pulmonary edema, asphyxia, chemical pneumonitis, and upper airway obstruction caused by edema.
- May cause liver and kidney damage. May cause methemoglobinemia, which is characterized by chocolatebrown colored blood, headache, weakness, dizziness, breath shortness, cyanosis (bluish skin due to deficient Chronic: oxygenation of blood), rapid heart rate, unconsciousness and possible death. Effects may be delayed.

Section 4 - First Aid Measures

- Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower Eyes: eyelids. Get medical aid immediately.
- Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing Skin: and shoes. Remove contaminated clothing and shoes.
- If victim is conscious and alert, give 2-4 cupfuls of milk or water. Get medical aid immediately. Do NOT Ingestion: induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.
- Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is Inhalation: difficult, give oxygen. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.
- For methemoglobinemia, administer oxygen alone or with Methylene Blue depending on the methemoglobin Notes to Physician: concentration in the blood.
- Methylene blue, alone or in combination with oxygen is indicated as a treatment in nitrite induced Antidote: methemoglobinemia.

Section 5 - Fire Fighting Measures

As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. Strong oxidizer. Contact with other material may cause fire. During a General fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Use water with caution and in flooding amounts. Some oxidizers may react explosively with hydrocarbons(fuel). May Information: accelerate burning if involved in a fire. Containers may explode when heated. Runoff from fire control or dilution water may cause pollution.
